

The hearing will be held on Tuesday, September 20, 1994, beginning at 9:30 a.m., in the Committee s main hearing room, 1100 Longworth House Office Building. The Honorable Ronald K. Noble, Assistant Secretary of the Treasury for Enforcement; the Honorable George Weise, Commissioner, U.S. Customs Service (Customs); and the Honorable Margaret Milner Richardson, Commissioner, U.S. Internal Revenue Service (IRS), will appear as witnesses at the hearing. The hearing will focus on: (1) Treasury s overall anti-money laundering enforcement efforts and the findings of Treasury s Money Laundering Taste Force, (2) recent and planned reforms to deal with money laundering, and (3) compliance and enforcement problems involving non-bank financial institutions. Forms 8300, the physical transportation of cash over U.S. borders, and suspicious transactions. In announcing the hearing, Subcommittee Chairman Pickle stated: The Department of the Treasury, including IRS and Customs, have major regulatory and law enforcement responsibilities in our Federal effort to address money laundering activities. 
